A tract of land in the Southeast quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

Beginning at the Southwest corner of the Southeast quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian; thence North 30 feet; thence East 30 feet; thence North 686.8 feet; thence North 89° 15' East 634.5 feet to the initial point of the tract hereby described; thence North 592.5 feet to a point on the center line running east and west through the said Section 17; thence along said center line north 89° 55' west to intersection with the easterly line of the 150 foot right of way granted to the State of Washington for State Secondary Highway No. 8-C by deed dated October 20, 1956, and recorded at page 499 of Book 42 of Deeds, Records of Skamania County, Washington; thence in a southeasterly direction following the easterly line of said 150 foot right of way to a point south 89° 15' west from the initial point; thence north 89° 15' east to the initial point;
