

FULL RECONVEYANCE

THE UNDERSIGNED, as Trustee under that certain Deed of Trust dated September 7, 1988, in which ALEX C. BOURDEAU and SHERRY G. BOURDEAU, husband and wife are Grantors, and LACAMAS COMMUNITY CREDIT UNION is Beneficiary, recorded October 24, 1988, in Book 111, Page 317, Auditor's file No. 106023, records of Skamania County, Washington, having received from the Beneficiary under said Deed of Trust a written request to reconvey, reciting that the obligations secured by the Deed of Trust have been fully satisfied, does hereby reconvey, without warranty to the persons entitled thereto, all of the right, title and interest now held by said Trustee in and to that property described in said Deed of Trust, situated in Skamania County, Washington, as follows:

Beginning at the quarter corner of the South line of Section 36, Township 3 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, thence West along the South line of said Section 36, 519.7 feet to the point of beginning; thence North 270 feet; thence West to the center of the channel of Rock Creek; thence following the center of the channel of Rock Creek Southerly 270 feet more or less, to the South line of the said Section 36; thence East to the initial point; together with an easement and right of way for use of the existing road over and across the Northeasterly corner of the tract; and subject to easements of record and an easement for the sewer line presently constructed and installed. And except the following described tract:

Commencing at a point 73 feet Northeast from the Northeast corner of the East truss of the Rock Creek Bridge on the North side of the Vancouver Road; thence running at right angles 100 feet in a Northwesterly direction to a large boulder 2 feet high; thence in a Southwesterly direction at right angles 73 feet; thence in a Southeasterly direction at right angles 100 feet to the East truss of Rock Creek Bridge; thence Northeasterly along the North line of Vancouver Road to the place of beginning; being that certain tract of land conveyed to Grant Ballard by deed recorded at Page 250 of Book N of Deeds, records of Skamania County, Washington. (Reference is to bridge existing August 7, 1916).

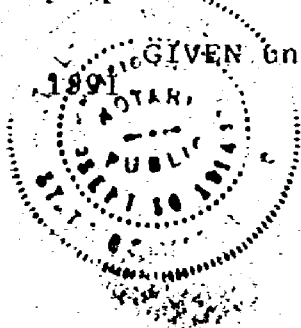
