ROAD MAINTENANCE AGREEMENT

THIS ROAD MAINTENANCE AGREEMENT made this day by and between ARCHIE M. RODGERS, JR. and ANITA RODGERS, husband and wife, hereinafter referred to as "A. Rodgers", and JAMES RODGERS and MARY RODGERS, husband and wife, hereinafter referred to as "J. Rodgers",

RECITALS

- 1. A. Rodgers is the owner of certain real property more particularly described in Exhibit "A" attached hereto and by this reference incorporated herein.
- 2. J. Rodgers is the owner of certain real property more particularly described in Exhibit "B" attached hereto and by this reference incorporated herein.
- 3. The properties of A. Rodgers and J. Rodgers as described in Exhibits "A" and "B" are served by a private road known as Dolan Road.
- 4. Said road is located upon real property more particularly described as follows:

County of Skamania, State of Washington:

A strip of land 30 feet in width, the centerline of which is described as follows:

BEGINNING at a point marked by an iron pipe which was formerly the centerline of a 30 foot road, said pipe being 198.4 feet South and 159 feet West of the section corner common to Sections 31 and 32. Township 2 North, Range 5 East of the Willamette Meridian, and Sections 5 and 6. Township 1 North, Range 5 East of the Willamette Meridian; thence North 34 39 40 West 216.28 feet to an iron pipe; thence North 5 17 00 West 200.2 feet to an iron pipe in a 30 foot roadway and the true point of beginning of the centerline described herein; thence North 48 41 00 West 171.70 feet to an iron pipe; thence North 66 24 00 West 34.1 feet to an iron pipe; thence North 66 24 00 West 34.1 feet to an iron pipe and the terminus of said centerline.

- 5. The parties hereto recognize and agree that it is in the common interests of all parties that said road be kept in a reasonable state of repair.
- 6. The parties hereto desire to enter into this written Road Maintenance Agreement to establish and provide for their respective obligations with respect to the maintenance of said road.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

GOOD FAITH COOPERATION: The parties hereto agree to cooperate with each other in good faith to keep said road in a reasonable state of repair in accordance with the provisions of this agreement. A good state of repair shall mean that the private road shall be usable and passable under all weather conditions for motorized vehicles.

Section 2. DECISION TO REPAIR: Any party deeming repairs to the road necessary or desirable may propose such repair to the other party. Such proposal shall describe the work proposed and the estimated cost thereof. Such proposal shall be in writing and delivered or mailed to the other party.

Section 3. ALLOCATION OF COST: Should the parties approve of the proposed repairs or maintenance, such repairs or maintenance shall be accomplished and the cost thereof shall be shared by the parties equally.

Section 4. DAMAGE TO ROAD: Should either party to this agreement, their agents or invitees, directly or indirectly, inflict or cause damage upon or to said road, that party shall be fully responsible for the cost of repairing such damage, and all such repairs shall be undertaken promptly.

Section 5. SUBDIVISION: Should either of the parties hereto subdivide or short plat their land, or build additional residences thereon, the owners of such new residences or of such subdivided or short platted properties of the land shall be deemed to have become parties to this Road Maintenance Agreement and shall pay their proportionate share of the cost of road maintenance and repair. In such event, the party selling a parcel or subdividing his property shall cause this agreement to be amended in writing and executed by such additional owner to state the revised proportionate shares of road maintenance and repair costs to be borne by the parties using said roadway.

Section 6. COVENANT RUNNING WITH THE LAND: The covenants and agreements expressed herein shall run with the land and shall

inure to the benefit of and be binding upon the parties hereto and their respective successors in title to the land described in Exhibits "A" and "B" attached hereto, or to any portion thereof.

Section 7. DURATION OF AGREEMENT: This Road Maintenance Agreement shall remain in effect perpetually or until revoked by all parties hereto, or by their respective successors in title, or until such road is dedicated to Skamania County as a public road.
