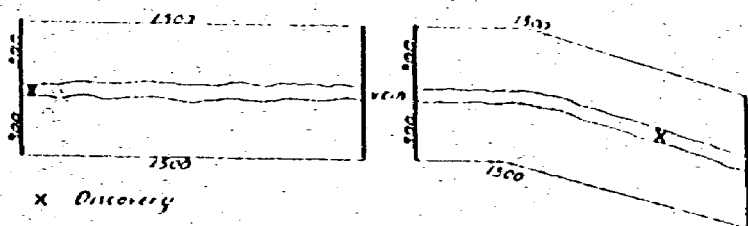


NOTICE OF MINING LOCATION

NOTICE IS HEREBY GIVEN That the undersigned who is/are (have declared all intention as a citizen of the United States, have discovered and have located and claimed and do hereby locate 1500 linear feet in length, and 600 feet in width on the lode claim Firebird #4, Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 750 feet in a Southerly direction to an end post marked No. 2, thence 600 feet in a Easterly direction to a corner post marked No. 3, thence 750 feet in a Northerly direction to a corner post marked No. 4, thence 750 feet in a Northerly direction to a corner post marked No. 5, thence 600 feet in a Easterly direction to a corner post marked No. 6, thence 1500 feet in a Southerly direction to said end post No. 2; hereby locating and intending to claim 3000 square feet in a N, E, S, and W direction from discovery to the deposit of precious metals & minerals in a end line, and 600 feet in the opposite direction from discovery to the North to South end line and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.

This claim is further described by reference to natural objects or permanent monuments, as follows: Claims sit on Federal owned land in Clifton Finchel National Forest, approximately 2 miles in a northerly direction on Forest service road 9091 to 091 from culvert on Firebird 1 and 2 then little in a South Easterly direction on 091 to compass marker on Firebird No. 5. These claims run contiguous of each other. Apex taken all direction.

This notice is placed at Discovery on post No. 1; posts are placed at each corner, and the name of this lode, and date of location, are placed on all posts.

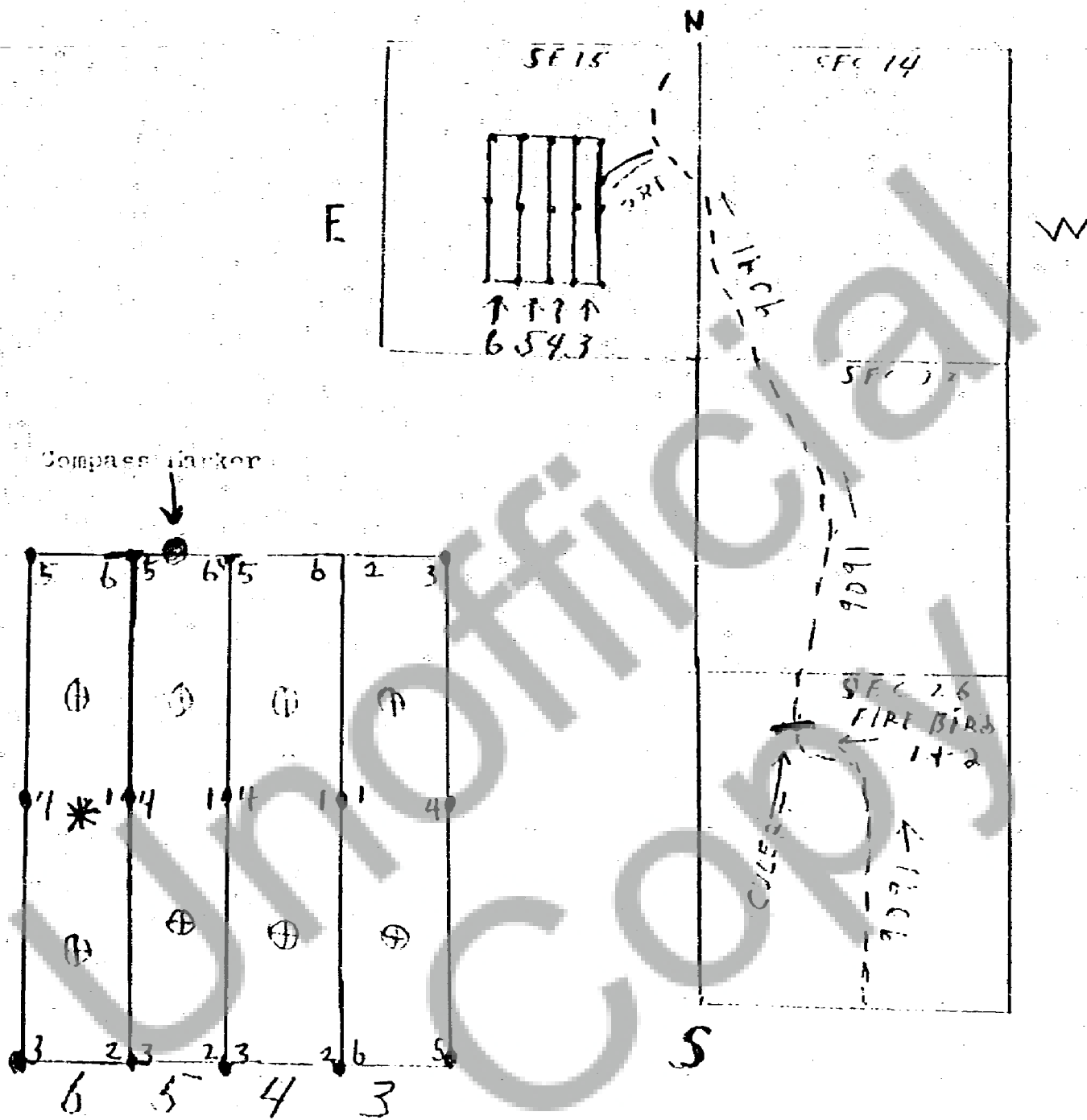
