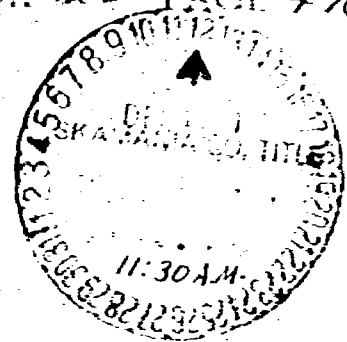

QUITCLAIM DEED
