QUITCLAIM DEED

THE GRANTORS, GEORGE AGUN and SHIRLEY B. AGUN, husband and wife, for no consideration and as a transfer to their revocable living trust, convey and quit claim to GEORGE AGUN and SHIRLEY B. AGUN, as Trustees under the GEORGE AGUN and SHIRLEY B. AGUN Revocable Living Trust Agreements, dated September 16, 1991, between GEORGE AGUN and SHIRLEY B. AGUN, as Settlers, and GEORGE AGUN and SHIRLEY B. AGUN, as Trustees, the following described real property, located in the County of Skamania, State of Washington, including any interest therein which Grantors may hereafter acquire.

The West half of the northwest quarter of Section 6, Township 1 North, Range 5 East of the Willamette Meridian;;

and ALSO

Commencing at the Northeast corner of Government Lot 2, in Section 1, Township 1 North, Range 4 East of the Willamette Meridian; which point is also the Northwest corner of the Southwest quarter of Section 6, Township 1 North, Range 5 East of the Willamette Meridian, running East on the quarter section line of said Section 6, 406 feet to a point; thence South on a line parallel with the East line of said Lot 2, 2010 feet, more or less, to the Cape Horn County road; thence Westerly along said Cape Horn County road to the West line of said Section 6; thence North along said section line to place of beginning, containing 20 acres, more or less.



