THE PARTIES HEREBY AGREE that that Agreement as to Status of Community Property dated June 4, 1964 and recorded with the Skamania County Auditor on June 15, 1964 under Book 53 at page 35, be and the same hereby is rescinded so that it shall be null and void and of no effect upon the death of either party.



