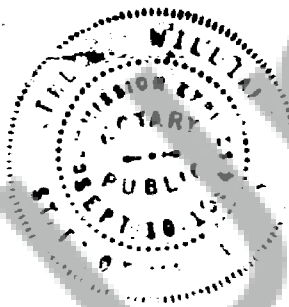

3. The land referred to in this deed is situated in the County of SKAMANIA, State of WASHINGTON, and is described as follows:

PARCEL 1:

The West half of the Southeast Quarter and the Southeast Quarter of the Southeast Quarter of Section 32, Township 2 North, Range 6 East of the Willamette Meridian, in Skamania County, Washington.

PARCEL 2:

That portion of the Northeast Quarter of the Northeast Quarter and Government Lots 6 and 7, situated in Section 5, Township 1 North, Range 6 East of the Willamette Meridian, lying Northerly of the right of way acquired by the State of Washington for State Road 14; EXCEPT that portion thereof described as follows: BEGINNING at Station 707 Plus, Plus 04.4 on the center line of State Road No. 8 according to the survey thereof said point of beginning being on the center line North and South through Section 5, Township 1 North, Range 6 East of the Willamette Meridian; thence following the center line of said State Road No. 8, North $65^{\circ}05'$ East 400 feet, more or less, to the intersection of said center line with the West line of the old survey of said State Road No. 8; thence North 275 feet; thence South $65^{\circ}05'$ West to a point due North of the point of beginning; thence South to the point of beginning.
