## STATUTORY WARRANTY DEED

THIS WARRANTY DEED is made this 3rd day of February, 1992 by and between E. THE GRANTOR, for and in consideration of the sum of twenty thousand dollars (\$20,000.00), receipt of which is hereby acknowledged, hereby grants, sells, releases, and conveys to the Grantee, all that certain real property located in Skamania County, State of Washington, to-wit:

A PORTION OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER, AND THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 34, TOWNSHIP 2 NORTH, RANGE 5 EAST OF THE WILLANETTE MERIDIAN, SKAMANIA COUNTY, WASHINGTON, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A 5/8" IRON ROD AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 34; THENCE SOUTH 01° 07' 30" WEST ALONG THE EAST LINE THEREOF, 20.04 FEET; THENCE NORTH 89° 00' 00" WEST, 1,322.64 FEET TO THE WEST LINE OF SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER; THENCE NORTH 91° 03' 40" EAST ALONG SAID WEST LINE, 16.90 FEET TO A 5/8" IRON ROD AT THE CENTER OF SECTION 34; THENCE NORTH 01° 03' 40" EAST ALONG THE WEST LINE OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER, 315.03 FEET; THENCE SOUTH 89° 00' 00" EAST, 1,321.30 FEET TO THE EAST LINE OF SAID SOUTHWEST QUARTER OF THE NORTHEAST QUARTER; THENCE SOUTH 00° 40' 50" WEST ALONG SAID EAST LINE, 301.77 FEET TO THE POINT OF BEGINNING.
