

**NARRATIVE**

THE PURPOSE OF THIS SURVEY WAS TO MONUMENT AND DESCRIBE A 30' X 30' EASEMENT PARCEL FOR FUTURE CONVEYANCE TO GTE, NORTHWEST FROM THE PRESENT LAND OWNER HELEN GORDON. A RANDOM TRAVERSE WAS CLOSED AND ORIENTED BETWEEN EXISTING MONUMENTS AT THE SOUTHWEST CORNER OF SECTION 1 AND THE MOST EASTERLY CORNER OF THE GORDON TRACT, WITH RADIAL TIES TO OTHER MONUMENTS SHOWN. CORNERS FOR THE 30' X 30' EASEMENT WERE SET RADIALY FROM THE ABOVE TRAVERSE POINTS. FIELD EQUIPMENT USED WAS A "ONE-SECOND THEODOLITE" AND AN "E.D.M."

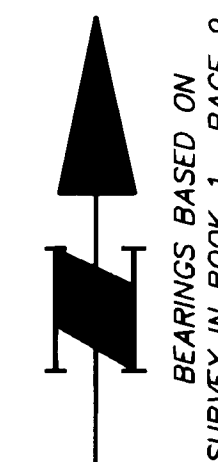
