LEGAL DESCRIPTION

The west half of the SE quarter ($W\frac{1}{2} SE\frac{1}{4}$); the south half of the SE quarter of the SE quarter ($SE\frac{1}{2} SE\frac{1}{4} SE\frac{1}{4}$) of section 32 township two north of range six E.M., excepting transmission line easement granted to the United States by deed recorded at page 511 book 28 of Deeds, records of Skamania County, Washington.

Also: NE quarter of NE quarter ($NE\frac{1}{4} NE\frac{1}{4}$) and lots 1,2,3,4,6 and 7 all in section five township one north of range six E.W.M., excepting a strip of land 100 feet in width deeded to the Portland and Seattle Railway Company. Excepting also right-of-way easement across lot 6.

Also excepting from the above the following tract deeded to Hugo Pedersen by deed recorded at page 221 Book "X" of Deeds, as follows:

Beginning at Station 707 plus 04.4 on the center line of State Road No. 3, Prindle to Skamania section, according to the survey thereof approved by the Highway Department of the State of Washington on the 9th day of October, 1925, said point of beginning being on the center line, north and south, through section 5 tp 1 N R 6 E.M., thence following the center line of said state road No. 3, N 65 deg. 05' E 400 feet more or less to intersection with the west line of the old survey of said state highway No. 8 thence north 275 feet, thence S 65 deg. 05' W 400 feet, to a point due north of the point of beginning, thence south to the point of beginning.

Reserving unto the Grantor the free possession and occupancy of said premises during his lifetime.

Also except that portion of the above described real property located in Section 5 township 1 range 6 E.M. lying south of State Highway No. 8
