AMENDED MEMORANDUM OF OPTION

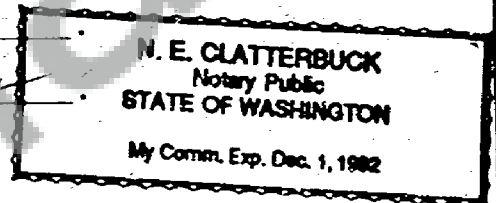

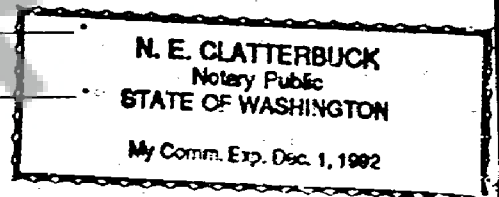
