ROAD MAINTENANCE AGREEMENT

This road maintenance agreement is for the access road known as River View Drive on the Krieger Short Plat. (see attached)

Agree:

1. all three owners of lots 1, 2, & 3 will share equally for maintenance of the access road of lot 1; owners of lot 2 & 3 will share equally in the maintenance of the access road of lot 2; owner of lot 3 will maintain the access road of lot 3.
2. that each of the landowners will use River View Drive in such manner as not to block the road, so that such other landowners shall be unable to use it.
3. that noisemaking vehicles such as motorcycles shall be used only for necessary transportation on said easement; that no heavy trucks, i.e., gravel trucks or equipment shall be used to break down said easement and do harm to it. No trucks, campers, trailers, boats, or inoperable vehicles may be parked or permitted to block the road.
4. If said road is substantially damaged by the activities of one landowner (including his agents or tenants) that landowner shall be responsible for repairing the damage at his own expense.
5. that there shall be unanimous agreement on sharing costs before repairs are begun.
6. the turn-a-round on lot #3 was installed as a county requirement for emergency vehicles, i.e., ambulances, fire trucks. Use of turn-a-round is by written permission only, other than access to lot #4 which has an easement through lot #3.

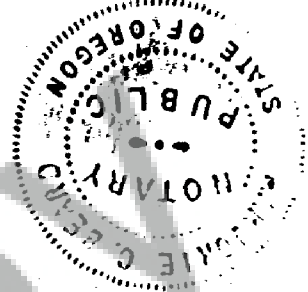
