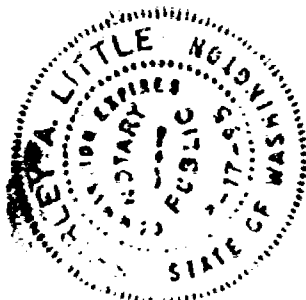
6. There were no estate taxes due as a result of demise.

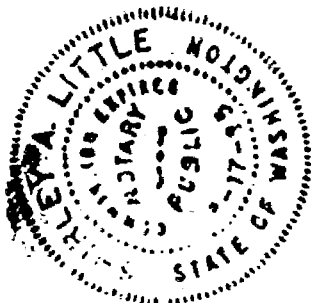
