II. FINDINGS

The Court finds that Defendant has duly executed a Confession of Judgment in the amounts indicated in the above Judgment Summary. The Court finds that the Confession of Judgment authorizes the entry of Judgment for a specified sum, states concisely the facts out of which the indebtedness arose, and otherwise complies with the requirements of Washington law.

III. JUDGMENT

On the basis of the foregoing Findings, it is hereby ORDERED, ADJUDGED AND DECREED that Plaintiff is awarded Judgment in the amount of \$7,116.76 against Defendant; \$53.62 for prejudgment interest accrued through May 25, 1992 at the rate of eighteen percent (18%) per annum pursuant to written agreement of the parties; ~~\$425.00 for Plaintiff's reasonable attorney fees incurred; and \$110.00 in costs and disbursements.~~ Post-judgment interest shall, pursuant to the agreement of the parties, accrue at the rate of eighteen (18%) per annum until the principal, interest, attorney fees and costs are paid in full.
