Beginning at the most Northerly Corner of Lot 2 of the Charles Seward Short Plat, recorded in Book 3 of Short Plats, page 181 Skamania County Records; thence North 18° 15' 58" East 115.93 feet; thence North 01° 02' 55" East 117.01 feet; thence North 07° 14' 40" West 147.56 feet; thence North 07° 14' 40" West 92.38 feet to the middle of the Private Road (Breedlove); thence South 69° 59' 12" West 190.35 feet to the middle of a Private Road; thence South 16° 46' 24" West 379.20 feet; thence North 02° 58' 12" West 103.35 feet; thence South 10° 09' 51" East 93.26 feet; thence South 30° 14' 07" East 32.79 feet; thence North 54° 49' 31" East 29.97 feet; thence North 66° 13' 10" East 88.46 feet, thence North 47° 54' 09" East 197.75 feet to the Point of Beginning.
