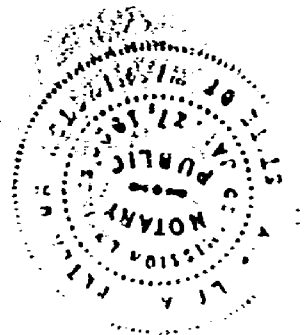

PARCEL I
