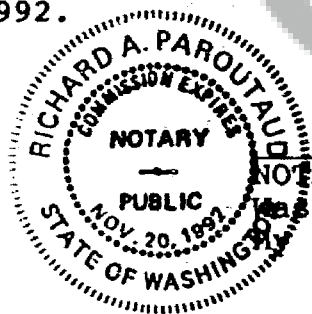
said service was closed on the 15th day of September, 1992 and sixty days have not elapsed since that time, that the amount of claimant's demand for said services is \$2,097.55; that no part thereof has been paid, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$2,097.55, in which amount he claims a lien upon all said logs. The said Lonnie Poteet also claims a lien on all said timber now owned by said Stimson Lumber Co. in said county to secure payment for the work and labor performed in hauling the said logs or other timber.
