EASEMENT DEED

The Grantors H. Wayne Burchett and Cheryl J. Burchett,  
husband and wife, for and in consideration of mutual benefit,  
do hereby give and set over to Albert Daniel Ketchmark and  
Joann Ketchmark, husband and wife, an easement for the purpose  
of burying a water line on a North and South bearing approximately  
350 feet West of the East line of that certain property located  
in Skamania County, Washington, and more particularly described  
as:

Beginning at the Southwest corner of the Southwest quarter  
of section 27, Township 2 North Range 6 E.W.M.; thence  
North 01 degrees 05' 09" East along the West line of said  
Southwest quarter 2,290.16 feet to the true point of  
beginning; thence South 89 degrees 08' 43" East 1,393.60  
feet to a point which bears North 01 degrees 05' 09" East  
2,295.32 feet and South 88 degrees 55' 59" East 1,393.58  
feet from the Southwest corner of the said Section 27;  
thence North 28 degrees 59' 33" West 386 feet, more or less  
to the North line of said Southwest quarter of section 27;  
thence Westerly along the North line of said Southwest  
quarter 1,200 feet, more or less, to the Northwest corner of  
said Southwest quarter of Section 27; thence South 01 degrees  
05' 09" West 334.70 feet to the true point of beginning.

Subject to easements and restrictions of record.

Subject Easement is to be located and maintained by the  
Grantees only for the purpose of burying the 1" water line across  
said property on the line described and transmitting water through  
said line and maintaining said line only to the extent that it is  
necessary to so do. This Easement shall not interfere with any  
Easements heretofore granted and it shall permit access of not more  
than 10 feet in width along said water line for the purpose of  
maintenance.
