White, husband and wife, as Sellers, and Phillip J. Waite, Jr. and Victoria P. Wait, husband and wife, as Purchasers, for the sale and purchase of the above-described real estate. The Grantees hereby assume and agree to fulfill the conditions of said Real Estate Contract.
