Southeast Quarter Northwest Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$ )

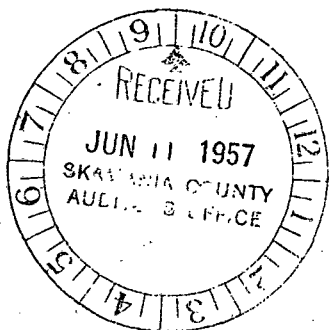
