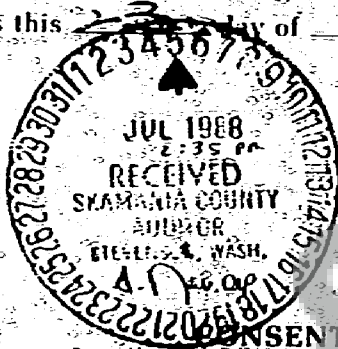
and all right, title, and interest in and to and under the said lease, to DAVID JOHANESSEN, JR.
