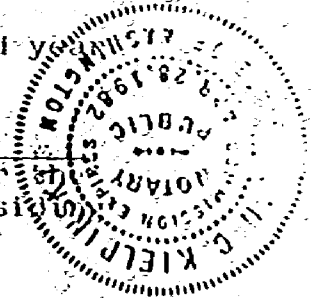

ARTICLE I  
Identification of Family

My immediate family now consists of my wife, ELSIE ANNA SPITLER, my son, RICHARD WHITNEY SPITLER, born December 11, 1951, and my daughter, JO ELLEN SIMLER, born December 1, 1946. The provisions of this Will in respect of my children and their issue shall apply not only to my children named above and their issue, but also to any and all children who may now or hereafter be born to or adopted by me and their issue.

ARTICLE II  
Deceased Children

I declare that I have no deceased children.

ARTICLE III  
Personal Representative

I hereby nominate and appoint my wife, ELSIE ANNA SPITLER, executrix of this my Last Will and Testament, to act without bond. In the event that my wife, Elsie Anna Spitler, is for any reason unable or unwilling to act as executrix hereof, I nominate and appoint my son, RICHARD WHITNEY SPITLER, to act as alternate executor hereof, also without bond.
