

Know All Men By These Presents, that I, H. C. Albee, the duly elected, qualified and acting Trustee in Bankruptcy of J. W. Russell, B. J. Russell, W. J. Smith, and J. H. Parulis, as individuals and as partners under the firm name of Russell, Smith & Co., Bankrupts, under and by authority of the District Court of the United States, for the District of Oregon, and for a valuable consideration to me, as said trustee, in hand paid by W. J. Sones, have demised, leased and farmed and do hereby demise, lease and farmlet to said W. J. Sones, and his assigns, for the term of two years next ensuing, from and after the first day of November, 1899, and also including the period from date hereof to said first day of November, 1899, a right-of-way one hundred (100) feet in width, being fifty (50) feet on each side of the center of the Old Road constructed across those certain real premises situated in the County of Skamania, in the State of Washington, being the North half of the Donation Land claim of Henry Shepard and wife, which said real premises are more particularly described in Book 7, pages 272 to 276 of the Mortgage Records of said Skamania County, reference to which is thereby made; also, the use of all the buildings erected upon the North half of said claim, with the exception of any buildings that may have been erected for school purposes, with the right to remove from said premises any of said buildings of which said W. J. Sones and his assigns have the use as aforesaid.

To Have and to hold the said leased premises unto the said W. J. Sones, and his assigns, for the term above mentioned; and I, said W. J. Sones, for myself and my assigns do hereby agree to yield and surrender up said premises at the termination of said term peaceably.



and are removed from the north half of said Donation Land claim which my mortgage covers, I am to be paid in addition the sum of three (\$3) Dollars per thousand feet for the amount of lumber on each building as removed, and all sums to be paid for giving my consent to said lease, and all sums to me to be paid for the lumber on said buildings that may be removed, shall be applied upon the notes by me held against said bankrupts, which said notes are secured by said mortgage.

It is further understood that said lease is made by virtue of my consent hereto, which is a part consideration thereof.
