F. W. LEADBETTER.

Know all men by these presents, that the Skamania Logging Company, a private corporation organized existing and doing business under and by virtue of the laws of the State of Oregon, for and in consideration of the sum of \$30,000, to it in hand paid, the receipt whereof is hereby acknowledged, has and by these presents does convey, sell, assign, transfer and set over to F. W. Leadbetter, his heirs, executors, administrators and assigns all the following described personal property to wit:

All of the logging camps outfit and equipment of the Skamania Logging Co., said camp being on Fractional Northwest Quarter of Section 6, Tp.2, North of Range 5, E. W. M. in Skamania County, near Skye, State of Washington, the said property including two Monkey engines, three horses, one wagon, one cow, all logging tools and equipment, cables and all personal property of every kind and description connected with or part said logging camp; also all personal property of every kind and description belonging to said company upon any of the land this day conveyed to the said F. W. Leadbetter, his heirs, executors, administrators and assigns, by the Skamania Logging Co. Also all the logs and timber cut upon said property or any portion thereof marked or unmarked belonging to said company, either situated-----

ed on said land or any part thereof or in any place on the Washougal River, or its North Fork, or any branches or tributaries thereof or situated upon the land logged by the company, or that may be contained in the boom of the LaCamas Boom Company, or the mouth of the said Washougal River, said loges representing 1,700,000 more or less; but all the logs cut upon any of the land or upon any of the places hereinbefore described which were on hand on the 1st of July, 1901, or that have been cut since said time are intended to be conveyed; it being the intention that the conveyances of all said personal property should take place as of July 1st, 1901, and all of the interests and property acquired since said date to become the property of the said F. W. Leadbetter, his heirs, executors, administrators and assigns.

It is further the intention to convey all of the property of the Skamania Logging Company of every kind and description save and except the consideration of this conveyance and the bills and accounts receivable.

To have and to hold the same unto the said F. W. Leadbetter, his heirs, executors, administrators and assigns for ever, and we, the vendors above named do hereby covenant to and with the said F. W. Leadbetter, his successors, administrators and assigns, that all of said-----

personal property is free from all incumbrances of every kind and description, and that we will warrant and defend the same against the lawful claims and demands of all persons whomsoever.
