This Indenture, Made this 29th day of July 1904 between Grace Udell and C. W. Udell of Stevenson of County of Skamania and State of Washington, parties of the first part, and Skamania Cooperative Telephone Ass. of Stevenson, County of Skamania and State of Washington party of the second part,  
Witnesseth, That the said parties of the first part in consideration of the covenants  
of the said party of the second part, hereinafter set forth do by these presents  
lease and demise to said party of the second part, the following described property  
to-wit: 60 feet of Lot 29 Block 2 in the Town of Stevenson, owned by said  
parties of the first part, in Skamania County, Washington.

To have and to hold the same to the said party of the second part, from the first

day of August 1904 to the first day of August 1905. And the said party of the second part, in consideration of the leasing the premises as above set forth, covenants and agrees with the parties of the first part, to pay to the said parties of the first part, as rent for the same the sum of Twenty-four Dollars, payable as follows, to-wit: Two Dollars per month payable on the first of each month.
