And I do, for myself, my heirs, executors and administrators and covenant and agree, to and with the said party of the second part, her executors, administrators and assign, to warrant and defend the sale of the said property, goods and chattels thereby made unto the said party of the second part his executors, administrators and assigns, against all and every person and persons whomsoever, lawfully claiming or to claim the same.
