Amos Underwood to O. & I. Ry Co.

Right of Way Agreement.

In consideration of the sum of One Dollar to the undersigned in hand paid, the receipt of which is hereby acknowledged, and the further sum of Fourteen hundred ninety-nine (\$1499) to be paid on the execution of the deed hereinafter mentioned, the undersigned have agreed and by these presents do agree on written request within 2 months from date, to sell and convey to the Portland and Seattle Railway Company, a Washington Corporation, free and clear of all incumbrances, a right of way for its railroad consisting of a strip of land one hundred (100) feet in width, forty fifty (50) feet in width on each side of the center line of the railroad of said Railway Company is located, stated out and to be constructed over and across: The West half of Lot one (1) and the East half of Lot Two (2) of Section Twenty-Three (23) in Township Three (3) North of Range Ten (10) East of W. M. in Skamania & Klaskanin Counties, State of Washington, including the preference right of the undersigned to purchase the portion of said shore lands contained within said strip, and upon payment of said sum above mentioned agree to make a good and sufficient deed to said Company for said strip, the Company to have the right to enter and construct its road across said premises in the meantime, and to pay said \$1499 upon delivery of said deed within said 2 months.
