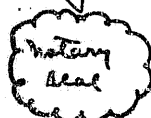

In consideration of the sum of one dollar to the undersigned in hand paid, the receipt of which is hereby acknowledged and the further sum of Nine hundred (\$900.00) Dollars, to be paid on the execution of the deed hereinafter mentioned, the undersigned has agreed and by these presents do agree, in written request within two months from date, to sell and convey to the Portland and

Seattle Railway Company, a Washington Corporation free and clear of all incumbrances, a right of way for its railroad consisting of a strip of land 100 feet in width, deep 50 feet in width on each side of the center line of the railroad of said Railway Company as located, or may hereafter be located, situated out and to be constructed over and across Lots 1, 2, 3 and four Sec. 31 Twp. 3 North Range 8 East W.M. Right of Way agreement.
