

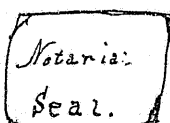

Right of Way Agreement.

In consideration of the sum of One Dollar to the undersigned in hand paid, the receipt of which is hereby acknowledged, and the further sum of Seven Hundred (\$700.00) Dollars to be paid on the execution of the deed hereinafter mentioned the undersigned have agreed and by these presents do agree on written request within two months from date, to sell and convey to the Portland and Seattle Railway Company, a Washington Corporation, free and clear of all incumbrances, the East thirty-three feet of Lots numbered thirteen, fourteen, fifteen and sixteen in Block five of the Town of Stevenson, Skamania County, Washington as shown

by the official plat of said Town now of Record in the office of the Auditor of said County, and the shore lands adjacent thereto, including the preference right of the undersigned to purchase the portion of said shore lands contained within said strip, together with the privilege of obtaining necessary material for construction of said railroad across said premises from lands outside of and adjacent to the above described strip, and upon payment of said sum above mentioned agree to make good and sufficient deed to said Company for said strip; Seller Retains Right to Remain in Possession six months from date of Payment without Payment of Rents Seller may Remove all Canters shingles and Post Office Cabment and all goods and fixtures.
