

Mineral Springs Hotel Co. & S. Macentney

This agreement entered into on this twenty-fourth day of March, 1906, by and between the Mineral Springs Hotel Company, a corporation of the State of Washington, party of the first part; and Samuel Macentney, party of the second part, witness:

That in consideration of the sum of one dollar (\$1.00) to it aforesaid, the receipt whereof is hereby acknowledged, the party of the first part hereby agrees to and with the party of the second part that pending the operation of the contract entered into by and between the party of the second part and T. L. Shepherd on the twenty-fourth day of March 1906, that the party of the first part will not incur indebtedness, obligations or charges to exceed the sum of Eight Thousand Dollars (\$8000.00) and that it will not sell its property and plant pending the operation of said contract for a sum less than that which would be sufficient to pay and discharge all the indebtedness against the party of the first part, leaving a sufficient amount remaining for the stock holders to be divided among themselves, in proportion to their stock so that the said party of the second part from such division would receive at least the amount that the said Shepherd agrees to pay the said party of the second part for the stock agreed by the party of the second part to be sold to the said Shepherd in the agreement aforesaid.
