W $\frac{1}{4}$, the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ and lots 5 and 6 in Sec. 31 T₃ S. N. R. 8 E. of Willamette Meridian in Skamania County, Washington; also all our right and interest in the standing timber upon the heretofore first described real property with the privilege to construct roads or skids over the same and to cut and remove the timber therefrom also the use of the water frontage for booming and landing purposes.

W. O. Hadley to J. G. Henry
