

Allen & Mary Haworth to Oregon Lumber Co.

I know all men by these presents that we Allen Haworth and Mary Haworth, of Washington County, Oregon, for and in consideration of the sum of Six Hundred Dollars, Gold Coin of the United States to us in hand paid by the Oregon Lumber Company, a corporation, the receipt whereof is hereby acknowledged, we do hereby grant, bargain, sell and convey to the said Oregon Lumber Company, its successors and assigns, all the fir, cedar, spruce, pine and hemlock timber capable of being manufactured into cord wood, saw logs, posts, spars or piling upon the South West quarter of the South West quarter of section Two, the South East quarter of the South East quarter of section Three, the North East quarter of the North East quarter of section Ten and the North West quarter of the North West quarter of section Eleven, all in Township Three North, range Nine East of the Willamette Meridian, in Skamania County, State of Washington, containing 160 acres of land, together with the right and privilege of going upon the said land and constructing railroads, tram or skid roads, and wagon roads upon the same for the purpose of removing the said timber herefrom, for the period of five years from the date of the execution of this deed.

It is expressly understood between the grantee and the grantors herein named that all timber remaining upon the said tract of real estate at the expiration of the period of five years from the date of the execution of this deed shall revert to the grantors, the grantees having by the terms of this deed and contract under which it is made five years from the date of the execution of this deed to remove all of the said timber.


