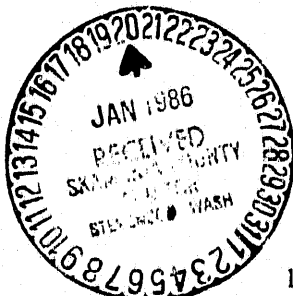

6. It is understood this document shall be recorded by the State of Washington in the county or counties wherein the lands affected by said right are located.

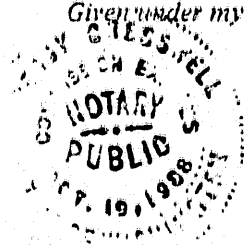
