

AGREEMENT BETWEEN ADJOINING OWNERS
TO ESTABLISH EASEMENT

THIS AGREEMENT, made the 22 day of August, 1986, between RICHARD A. WITHEY and KATHERINE L. WITHEY, husband and wife, hereinafter referred to as "Grantors" and RAYMOND A. BREITENBAUGH and ROXANA M. BREITENBAUGH, husband and wife, hereinafter referred to as "Grantees", provides as follows:

The parties have an interest in adjoining real estate situated in the City of Washougal, County of Skamania, State of Washington, and described, respectively, on "Exhibit A" and "Exhibit B" attached hereto.

The parties to this agreement desire to create an easement upon the property of the Grantors and their successors in title.

NOW, THEREFORE, an easement for a drain field for the existing septic system of the Grantees is created over the west one acre of the land owned by the Grantors, which land is more specifically referred to in "Exhibit A" attached hereto.

IN CONSIDERATION for the creating of the above easement, Grantors acknowledge receipt of the sum of Ten Dollars as full consideration for the creation of said easement.

IT IS FURTHER AGREED that Grantees and their successors shall solely bear all costs and expenses of the maintenance of said drain field and shall restore the west acre of the Grantors' property to it's former condition after their maintenance work is completed. Further, nothing shall be done to damage or destroy any of the existing standing timber currently on Grantors' property.

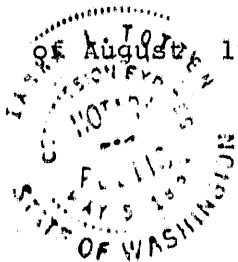

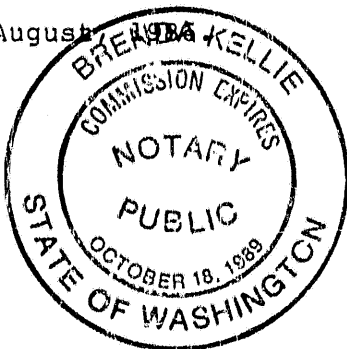
