SCHEDULE C

The land referred to in this deed is situated in the State of Washington
County of Skamania

and is described as follows:

A tract of land located in ROSELAWN EXTENSION according to the official plat thereof on file and of record at Page 65 of Book A of Plats, Records of Skamania County, Washington, described as follows:

Lot 1, 2, 3, 4 and 5, of Block 5 of ROSELAWN EXTENSION aforesaid; and a tract described as follows: Beginning at a point on the East line of Block 4 of said ROSELAWN EXTENSION, 5.20 feet North 36° 03' 31" West of the Southeast corner of said Block 4; thence North 36° 03' 31" West 126.80 feet to the Northeast corner of Lot 6, Block 4, ROSELAWN EXTENSION; thence North 89° 48' 58" East along the South line of Lot 7 of said ROSELAWN EXTENSION 30.85 feet to the True Point of Beginning; thence continuing North 89° 48' 58" East 30.85 feet to the West line of Block 5 of said ROSELAWN EXTENSION; thence South 36° 03' 31" East along the West line of said Block 5, 96.00 feet; thence South 60° 09' 26" West 25.15 feet; thence North 36° 03' 37" West 111.44 feet to the True Point of Beginning.

TOGETHER WITH an easement and right of way for an access road and for public utilities over and across Lot 7 of Block 4 of ROSELAWN EXTENSION aforesaid and over and across the North 25 feet of Block 1 of UPPER CASCADES ADDITION according to the official Plat thereof on file and of record a Page 69 of Book A of Plats, Records of Skamania County, Washington.
