## 1. History of Corner Establishment and Subsequent Restoration: 2. Description of Evidence Found:

GLO in 1901 set a post, from which bear:

32" fir, N50E, 100 links (66.00 ft.)

20" fir, S03E, 64 links (42.24 ft.)

W.E. Blair, LS, in October, 1933 in a survey for Wauna Lake Club, found chopped out stump at call of NE tree. Found position of other BT, which had slid down the hill, and the log had visible scribing.

From the position of both BT,s he set a 2"x6" boiler tube 30" in the ground, next to his previously set wooden stake. From the position bear:

Large stone, S67E, 11 ft. Marked for 1/4 corner

2. Found boiler tube, with rotted scribed post lying alongside  
Found stone, but no mark noted

A proportioned corner lying East of this position was not accepted.

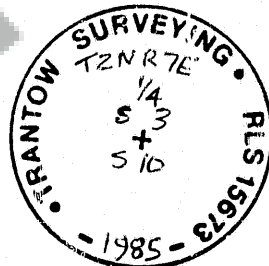
Set a 1 1/2"x30" galvanized iron pipe 18" in the ground, in a 2x2x10" mound of stone, from which bear:

18" D-fir, S11E, 18.03 ft. to center of tree scribed S10WT

20" D-fir, S41W, 17.58 ft. to center of tree scribed S10WT

Stone, S67E, 11 ft. as called

Both trees marked with Longview Fibre Co. witness tags
