Name: Corner to Sections 21, 22, 27 & 28 Corner No.:
DLC, HES, Tract, Mining Claim, Indian Allotment, Federal Reserve, Townsite.

1. History of Corner Establishment and Subsequent Restoration: 2. Description of Evidence Found:

GLO in 1892 set a post for this corner, from which bear:

- 8" fir, N22E, 188 links (124.08 ft.)
- 48" dead fir, S45E, 18 links (11.88 ft.)
- 8" fir, S70W, 109 links (71.94 ft.)
- 12" fir, N80W, 120 links (79.20 ft.)

2. Found NW tree, a cut stump, 40" diameter. Cut into and found scribing "BT"
Found SE tree, a cut 48" stump, with narrow, 3/4"x8" rotted face, no visible scribing.
Found a pointed stone in a cluster of four stones. Calls from the two found BT's intersect across the top of the center stone, at which point I accepted the center stone as the corner. I replaced the center stone with an iron pipe with brass cap.

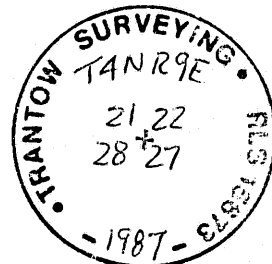

3. Describe Monument, Accessories and Corollary Data to Perpetuate this Corner Location. Diagram corner and indicate meridian and reference to map of record.

Set a 1 1/2"x30" galvanized iron pipe with 2 1/2" brass cap 23" in the ground, in a cluster of four stones, from which bear:

- 40" D-fir cut stump, N82W, 76.52 ft. to face scribed BT
 - 48" D-fir cut stump, S44E, 12.03 ft. to face
 - 20" D-fir stump, S28W, 6.16 ft. to nail at side of center of tree
 - 16" D-fir stump, N11E, 33.45 ft. to nail at side of center of tree
- All are marked with aluminum witness tags
Corner falls in a c. 1975 clearcut, about 150' East of a ridge

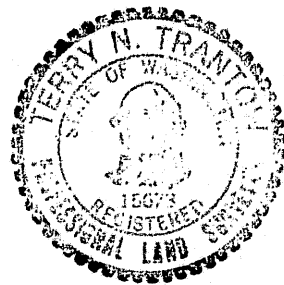
