Notice is hereby given that Merle L Blankenship of Coulitz county, State of Washington, claims a lien upon 20,780 Bd.Ft. or 347,970 lbs of Logs, being about 550 Logs in quantity, which were cut or manufactured in Skamania county, State of Washington, are marked thus Brand Z-11, yellow paint and are now lying in Alder Creek Lbr Co <sup>Storage</sup>, for labor performed upon and assistance rendered in Transporting said logs; that the name of the owner or reputed owner is Alder Creek Lumber Co.; that Joe Zumstein Log employed said Merle L Blankenship to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said Joe Zumstein Log agreed to pay the said Merle L Blankenship for such labor and assistance \$4.75 Per 1000 lbs that said contract has been faithfully performed and fully complied with on the part of said Merle L Blankenship, who performed labor upon and assisted in Transporting said logs for the period of 11 days; that said labor and assistance were so performed and rendered upon said Joe Zumstein Log between the 10 day of December and the 20 day of December; 1986 and the rendition of said service was closed on the 20 day of December, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$1,652.85; that no part thereof has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$1,652.85, in which amount he claims a lien upon said Logs + Other Properties If said Merle L Blankenship also claims a lien on all said Logs + Other Properties now owned by said Alder Creek Lbr. Co. + Joe Zumstein Log of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
