

## CLAIM OF LIEN

ESSEX TREE SERVICE, INC., Claimant, vs.  
WILKINS KAISER & OLSEN, INC. (WKO)

NOTICE IS HEREBY GIVEN that ESSEX TREE SERVICE, INC., of Skamania County, State of Washington, claims a lien upon a deck or decks of logs, being about 600,000 board feet in quantity, which were cut or manufactured in Skamania County, Washington, are marked thus *2*, and are now lying in the Log Yard of WKO, INC., at Carson, in Skamania County, Washington, for labor performed upon and assistance rendered in falling and bucking said logs; that the name of the owner or reputed owner is WKO, INC.; that JOE ZUMSTEIN LOGGING employed ESSEX TREE SERVICE, INC. to perform such labor and render such assistance upon the following terms and conditions, to-wit:

The said JOE ZUMSTEIN LOGGING agreed to pay the said ESSEX TREE SERVICE, INC., for such labor and assistance, \$12.00 per thousand board feet for merchantable logs and \$10.00 per thousand board feet for pulp logs; that said contract has been faithfully performed and fully complied with on the part of said ESSEX TREE SERVICE, INC., who performed labor upon and assisted in falling and bucking said logs for the period of three months; that said labor and assistance were so performed and rendered upon said logs between September, 1986 and the 15th day of December, 1986, and the rendition of said services was closed on the 15th day of December, 1986, and sixty days have not elapsed since that time; that the amount of claimant's demand for said service is \$15,000.00; that no part thereof has been paid and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$15,000.00, in which amount the Claimant claims a lien on all said logs now owned by said WKO, INC. of said county to secure payment for the work and labor

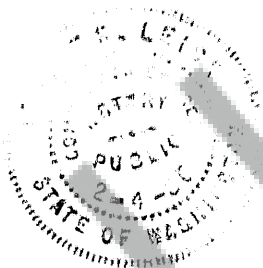
