R.L. Wilson and Son Claimant, vs COLUMBIA VISTA CORP and JOE ZUMSTEIN Logging

Notice is hereby given that R.L. Wilson and Son of CLACK county, State of Washington, claims a lien upon 14,750 BF of LOGS, being about 80 LOGS in quantity, which were cut or manufactured in SKAMANIA county, State of Washington, are marked thus Z11-YELLOW PRINT, and are now lying in COLUMBIA VISTA YARD, for labor performed upon and assistance rendered in TRANSPORTING said LOGS; that the name of the owner or reputed owner is COLUMBIA VISTA MILL; that JOE ZUMSTEIN Logging employed said R.L. Wilson and Son to perform such labor and render such assistance upon the following terms and conditions, to wit:

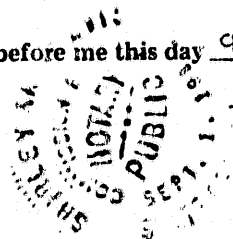
The said JOE ZUMSTEIN Logging agreed to pay the said R.L. Wilson and Son for such labor and assistance STATE RATE; that said contract has been faithfully performed and fully complied with on the part of said R.L. Wilson and Son, who performed labor upon and assisted in TRANSPORTING said LOGS for the period of 30 DAYS; that said labor and assistance were so performed and rendered upon said JOE ZUMSTEIN Logging between the 5th day of DECEMBER and the 12 day of DECEMBER and the rendition of said service was closed on the 22nd day of DECEMBER, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$802.08 ^{LAST BILLING DATE}; that no part thereof has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$802.08, in which amount he claims a lien upon said LOGS. The said R.L. Wilson and Son also claims a lien on all said LOGS now owned by said COLUMBIA VISTA CORP and JOE ZUMSTEIN Logging of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
