LIMITED POWER OF ATTORNEY

1. Appointment of Attorney-in-Fact. KAYE D. BOWERS, as "principal", hereby appoints LYLE BOWERS as her attorney-in-fact.

2. Purpose. Principal has complete trust and confidence in attorney-in-fact. Principal desires to have attorney-in-fact available to act on behalf of principal to sell and convey my interest, separate or community, in all the lands and real estate situate at Northwoods Cabin Site No. 206, more specifically described in the attached Exhibit A, and by this reference incorporated herein, for such price or prices and on such terms as my said attorney-in-fact shall think best, and to execute, acknowledge, and deliver good and sufficient deeds and conveyances for the same, either with or without covenants and warranty, and generally to act in the premises as effectually as I could do if personally present, hereby ratifying and confirming all that my said attorney-in-fact shall lawfully do by virtue hereof.

The attorney-in-fact and all persons dealing with the attorney-in-fact may rely on this limited power of attorney and assume its validity so long as the person so relying does not have actual knowledge of the revocation or other termination of the power. Any action so taken in justifiable reliance on this power shall be binding upon the principal and her successors and representatives.
