for labor performed upon and assistance rendered in logging and loading said logs; that the name of the owner or reputed owner of said logs is FOREST SERVICE/BALD KNOB; that BALD KNOB employed SARGENT LOGGING, INC. to perform such labor and render such assistance upon the following conditions, to-wit:

The said BALD KNOB agreed to pay SARGENT LOGGING, INC. for such labor the sum of \$70.00 per thousand.

That said contract has been faithfully performed and fully complied with on the part of SARGENT LOGGING, INC., who performed labor upon and assisted in the logging and loading of said logs for the period of April 21, 1987, through May 18, 1987; and the rendition of such service was closed on the 18th day of May, 1987, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$2,520.00; that no part thereof has been paid, and there is now due and remaining unpaid thereon, after deduction of all credits and offsets, the sum of \$2,520.00, in which amount SARGENT LOGGING, INC. claims a lien upon said logs. SARGENT LOGGING, INC. now also claims a lien on all said logs now owned by BALD KNOB to secure payment for the work and labor performed in obtaining, hauling and securing the said logs herein described.
