1. History of Corner Establishment and Subsequent Restoration:

In 1977, Hagedorn, Inc. set a 5/8" rebar for this corner and referenced 3 trees. Then in 1985, Hagedorn remonumented the corner with a USFS aluminum monument, as described below, and added one additional reference; (see surveys recorded in BOOK 1, PAGE 142 and in BOOK 2, PAGE 236 in the County of Skamania). Then on July 18, 1988, HAMPSTUR CORP. found and maintained the corner as described below, while working on a corner restoration project for PLUM CREEK TIMBER CO., under the direction of C. Hampton, LS.#18,087.

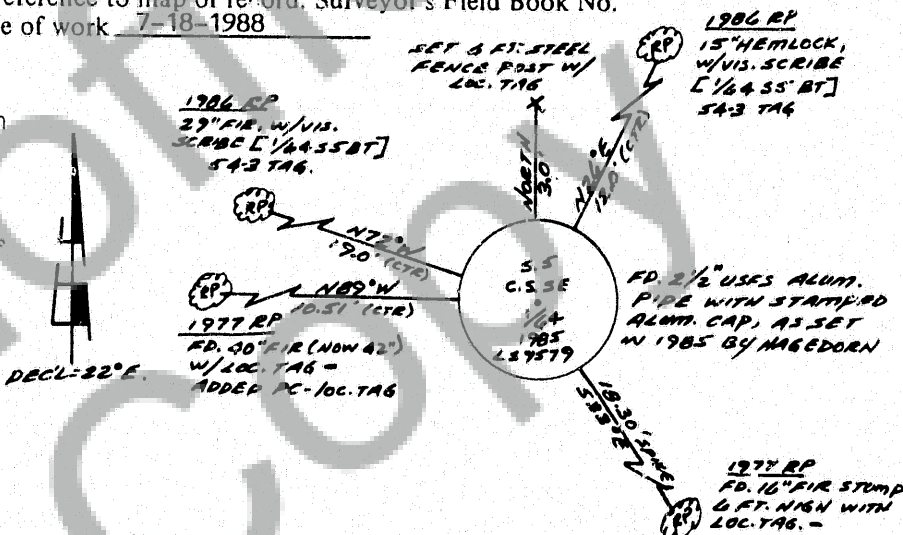
2. Description of Evidence Found:
