1. History of Corner Establishment and Subsequent Restoration:

In 1977, Hagedorn, Inc. established this corner with a 5/8" rebar and referenced 3 trees, as indicated on their survey map recorded in BOOK 1 of SURVEYS at PAGE 142, with Skamania County. Then in 1985, Hagedorn, Inc. remonumented the corner with the USFS aluminum mon. as shown in the diagram below, and re-referenced the corner as indicated on their survey map recorded in BOOK 2 of SURVEYS at PAGE 236, with Skamania County. Then on July 18, 1988 HAMPSTUR CORP. maintained the corner, as shown in the diagram below, while working on a corner restoration project for PLUM CREEK TIMBER CO., under the direction of C. Hampton, LS #18,087.

2. Description of Evidence Found:

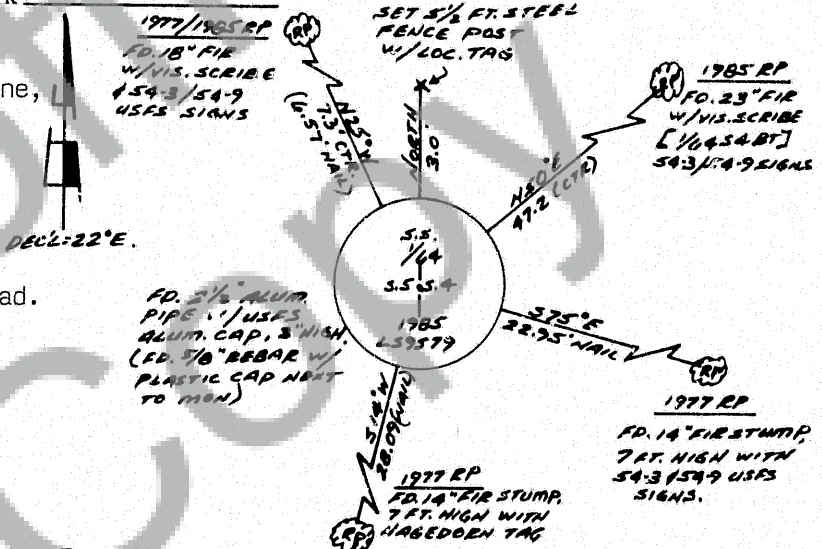

-on an existing East-West cutting line, with timber to the North and reprod to the South.

-the corner lies on a flat area, approx. N78°W--150 ft. from a bend in road "10", which bears S82°E-S35°W; at a point which is 0.03 mi. West of the "5 mile post" on the road.
