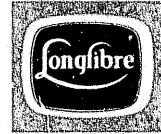

Please contact me if you have any questions about our exchange or if you see any problems that can be resolved in advance.

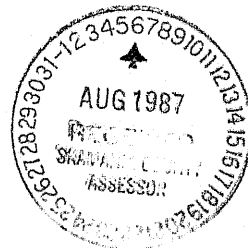
