## 1. History of Corner Establishment and Subsequent Restoration:

This corner was originally established in 1900, by Lewis Shelton, under GLO contract #552. The corner was then remonumented with a 1"x36" iron pipe with brass cap by Chester Pecore in 1921, while working under GLO contract, group #19. He added 2 additional BT's at that time. Then HAGEDORN, Inc. found the corner in 1977 and added additional references during a survey in Section 5. Then on July 29, 1988, R. Bogdon (from HAMPSTUR CORP.), located the above monument and added one additional RP and a steel reference post, as shown in the diagram below, while working on a "corner restoration" project for PLUM CREEK TIMBER CO., under the direction of C. Hampton, PLS #18,087.

## 2. Description of Evidence Found:

## 1900 ORIGINAL BT's:

-22" Fir, N54 $\frac{1}{2}$ °E--37 $\frac{1}{2}$  lks.; found a dead stub at record location (was dead in 1921).

-24" Fir, S07 $\frac{1}{2}$ °E--15 lks.; found a dead stub at record location (was dead in 1921).

1921 ORIGINAL GLO MONUMENT: found the 1"x36" iron pipe with brass cap, as described above and shown in the diagram below.

## ORIGINAL 1921 BT's:

-10" Hemlock, N12°E--18 lks.; fd. a 23" live Hemlock (leaning), see diagram below.

-10" Cedar, S20°W--16 lks.; fd. a 23" live Cedar, with a partially vis. face, see below.

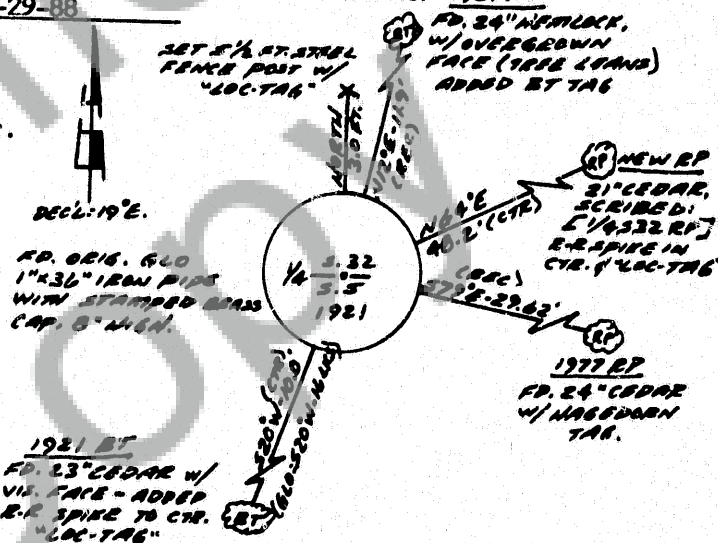
