## 1. History of Corner Establishment and Subsequent Restoration: 2. Description of Evidence Found:

GLO in 1879 set a dogwood post for this corner, from which bear:

15" fir, S70E, 7 links (4.62 ft.)

12" fir, N75W, 5 links (3.30 ft.)

1938 map of the Bonnaville-Coulee Line No. 2 indicates "ties" to this corner along the entire section line. Skamania County employees in 1966 set an iron pipe for this corner using BPA information, and indicating "Richmond 1938" in their notes.

## 2. Evidence found. Found an 3/4" iron pipe and Skamania Co. line tag on steel post. Using BPA information, the distance to Line No. 2 calculated 520.63 feet on the section line. The area has been previously logged and now supports a 30-year old 2nd growth stand of Douglas-firs. From this iron pipe, lengths of section calculate as follows:

2533.45 Nori
