

LIEN NOTICE

DALE ULLFERS, Claimant vs MENASHA CORPORATION, J & D TIMBER
FALLING, AND WASHINGTON STATE DEPARTMENT OF NATURAL RESOURCES

Notice is hereby given that DALE ULLFERS of Skamania County, State of Washington, claims a lien upon a quantity of timber being about 2,300,000 feet in quantity which was cut in Skamania County, State of Washington and is now lying in property owned by the Department of Natural Resources, State of Washington, approximately eighteen (18) miles north of the town of Carson in a timber sale denominated as "Huckleberry Sale." This claim is made for labor performed upon said timber; rendered in cutting, falling, and bucking said timber (including furnishing of materials), all having a value of ONE THOUSAND NINE HUNDRED SIXTY ONE AND 02/100 (\$1,961.02). Additionally, the lien claimant makes claim for interest at the highest legal rate allowed by the State of Washington together with attorneys' fees in the amount of not less than \$750.00, all of which the claimant will ask to be trebled as exemplary damages for outrageous conduct on the part of MENASHA CORPORATION. The owner, or reputed owner, of subject logs is MENASHA CORPORATION. MENASHA CORPORATION employed J & D TIMBER CUTTING COMPANY to do subject logging, and MENASHA CORPORATION, through J & D TIMBER CUTTING COMPANY, employed this claimant to perform such labor and render such assistance as he has rendered. MENASHA CORPORATION and J & D TIMBER CUTTING COMPANY agreed to pay the claimant at the rate of FIFTEEN DOLLARS AND NO/100 (\$15.00) per hour together with repayment of his expenses and the contract has been faithfully performed and fully complied with on the part of the claimant who commenced the contract on or before the 27th day of July, 1988 and last performed services on said contract on the 19th day of August, 1988. Sixty days have **not** elapsed since the performance of the last regular services on said contract, demand has been made on numerous occasions to all of the above named respondents, and payment has been acknowledged as due and owing, but payment has not been made. Claimant now claims a lien upon said timber and all of its product. Claimant also claims a lien on any and all property, including monies, held in this county or in this state by the above named respondents.
