(1) Pertinent Corner History:

The original survey was conducted by Deputy Surveyors, Lewis
Vanvleet and John Newsom under contract No. 7, dated April 29,
1859. Set a post at 40.00 chains North of the Southwest corner.
B.T.'s as follows:

- 8" diameter Dogwood, North 65° West, 40 links.
- 6" diameter Dogwood, South 20° East, 30 links.

1881 G.L.O. survey of Section 33 by Charles Sears. Found B.T.'s in
good condition, but post was gone. Set new post at corner.

1897 H. Witherell (County Surveyor) set a new stake at corner the
old stake was gone, C.O. Williams was a chainman.

1903 C.O. Williams (County Surveyor) surveyed to corner from East.
He went to 1/4 corner "which is est. by govt. witness
trees". Owners (Carl Lindstrom & P.E. Vettic) of East half,
Northeast quarter, section 33 & Northwest quarter of Section 34.,
were chainman.

In November 1988, Jerry C. Olson had conducted a survey of a portion of Southeast quarter, Northeast quarter, Section 33, Township 2 North, Range 6 East, Willamette Meridian, Skamania County. As detailed in his narrative on the quarter corner 33/34, Township 2 North, Range 6 East, Willamette Meridian. J.C. Olson set a 1" iron pipe with a Brass Cap. B.T.'s as follows:
 20" Fir with R.R. Spike and O.E. Tag, North 37° West, 5.17.
 10" Maple with R.R. Spike and O.E. Tag, East, 28.55
 14" Maple with R.R. Spike and O.E. Tag, South 83° West, 11.66.

(2) Evidence Found at the Corner:

No original evidence was found. Found 2 1/2" Brass cap; stamped Olson. East quarter corner, Section 33, located .30 above ground surface.
